2. The MDLF now invites sealed Bids from eligible Bidders to the “**Supply of IT Equipment for O&M for benefited West Bank municipalities**”. The bid is comprised of **two (2) lots**:

***Lot No. 1: Supply of Servers, Cabinets, 6 KVA UPS, KVM + TFT, and Switches***
