The Palestine Liberation Organization, for the benefit of the Palestinian Authority, has received additional financing (AF) in the form of a grant in the amount of US\$2.00 million from the Global Partnership for Results-Based Approaches (GPRBA) and US\$ 1.25 million from the Partnership for Infrastructure Development Multi-Donor Trust Fund (PID-MDTF) to the Palestinian Authority (PA); for the Gaza Solid Waste Management Project (GSWMP) towards the cost of additional financing project.

Municipal Development and Lending Fund now invites sealed Bids from eligible Bidders for **Closure of Existing Deir Al Balah Dumpsite**. Ref. **GZ-MDLF-192161-CW-RFB**.

1. Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" July 2016 ("Procurement Regulations"), and is open to all Bidders as defined in the Procurement Regulations.
2. Interested eligible Bidders may obtain further information from (The Municipal Development and Lending Fund-MDLF, MDLF Procurement Department) and inspect the bidding documents at the address given below at during office hours 08:00 A.M. to 03:00 P.M. from January 19, 2021 to February 21, 2021.
3. Qualifications requirements are presented in the Bidding Documents.
4. Qualifications requirements include a list of technical, financial and legal requirements. Additional details are presented in the Bidding Documents.

A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non-refundable fee of 150 Euro or equivalent amount of freely convertible currency. The method of payment will be in a direct bank deposit to The Municipal Development and Lending Fund-MDLF account number (174434), The National Bank, Al Masyoun Branch.
6. Bids must be delivered to the address below on or before February 21, 2021 - 12:00 noon. Electronic Bidding will *not* be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on February 21, 2021 - 12:00 noon.
7. Bids shall be valid for a period of (90) day after the bid submission deadline date and must be accompanied by a Bid Security of 20,000 Euro (€). The Bid Security should be valid for 118 days after the bid submission deadline date.
8. **Grant is VAT included, bidders to price with VAT.**
