The Palestine Liberation Organization, for the benefit of the Palestinian National Authority (PNA), has received an initial financing of *EUR 130 Million* from the World Bank-International Development Association (IDA), PA, KFW, Denmark, SDC, VNG, GIZ and AFD towards the cost of the 3<sup>rd</sup> phase of the Municipal Development Program (MDPIII).

The Municipal Development and Lending Fund (MDLF) as an implementation agency for the project intends to use part of the grant for consulting services to hire individual Consultants to conduct the above-mentioned assignments which will be conducted in selected municipalities in West Bank.

The individual consultant shall provide technical assistance to MDLF and the targeted municipalities in **West Bank** clusters in implementing environmental management of MDPIII Cycle II in compliance with MDP Operation Manual, Environmental and Social Management Framework and in line with the Land Acquisition and Livelihood Framework, the individual consultant expected to conduct all the activities related to the assignment scope as indicated in the TOR, over a period of 24 months and it is expected to start in February 2020.
