The Palestine Liberation Organization, for the benefit of the Palestinian Authority (PA), has received financing in the amount of US\$ 29.76 Million from the World Bank-International Development Association (IDA), the French Development Agency (AFD), and the European Union (EU) towards the cost of the Gaza Solid Waste Management Project (GSWMP). The Municipal Development and Lending Fund (MDLF), as the delegated implementing agency, intend to apply part of the proceeds of this grant to payments under the Contract for [Construction of Rafah Transfer Station](#), Ref. [1.1.4](#).
2. The Municipal Development and Lending Fund - MDLF now invites sealed bids from eligible and qualified bidders for [Construction of Rafah Transfer Station](#). [The project period is 9 months](#).
3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the MDLF Procurement Manual- based on the World Bank Procurement Guidelines and is open to all bidders from Eligible Source Countries as defined in the Bidding Documents.
4. Qualifications requirements are presented in the Bidding Documents.
5. Interested eligible bidders may obtain further information from (The Municipal Development and Lending Fund-MDLF, MDLF Procurement Department), and inspect the Bidding Documents at the address given below at 8:00 a.m. to 04:00 p.m. from Sunday to Thursday.
6. Qualifications requirements include a list of technical, financial and legal requirements. Additional details are presented in the Bidding Documents.

A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee of [100 Euro](#) or equivalent amount of freely convertible currency. The method of payment will be in a direct bank deposit to The Municipal Development and Lending Fund-MDLF account number ([174434](#)), [The National Bank](#), Al Masyoun Branch.
8. Contractors are invited to attend the site visit and the pre-bid meeting which shall be held on [26 July, 2018 at 10:00 a.m. o'clock](#), the pre-bid meeting shall be held at the Municipal Development and Lending Fund, Gaza branch office at the address below.
9. Bids shall be valid for a period of [\(90\) day](#) after the bid submission deadline date and must be accompanied by a Bid Security of [20,000 Euro](#). The Bid Security should be valid for [118 days after the bid submission deadline date](#).
10. Bids must be delivered to the address below [at or before 10:00 a.m., 12 August, 2018](#). Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened physically in the presence of the bidders' representatives who choose to attend in person at the address at [10:00 a.m., 12 August, 2018](#).
