



# Invitation for Bids (IFB) Works & Equipment

Project name: **CONSTRUCTION OF JERICHO SLAUGHTERHOUSE**

1. The *Municipal Development and Lending Fund (MDLF)*/Jericho Municipality has received funds from the Agence Française de Développement (the French Development Agency) towards the cost of *the Urban and Economic Multi Site Regeneration Project- MSR Project*. It is intended that part of the proceeds of these funds will be applied to eligible payments under the contract for the **“Construction of Jericho Slaughterhouse”**.
2. The *Municipal Development and Lending Fund (MDLF)* now invites sealed bids from eligible bidders for the construction and completion of *Jericho Slaughterhouse*. The Project will encompass the construction and commissioning of a modern state-of-the-art Halal Slaughtering Facility in Jericho; it is composed of two buildings; one cattle/ sheep slaughterhouse with an area of 1,464 m<sup>2</sup> and a poultry slaughterhouse building with an area of 1,028 m<sup>2</sup>. The works involve the construction and commissioning of the slaughterhouse facilities (including the supply and installation of slaughterhouse equipment) and external services which include, but are not limited to; a waste water treatment plant, septic tank, access roads, landscape works, a etc. as per the drawings and BOQ (“the Works”).
3. Interested eligible bidders may obtain further information from and inspect the bidding documents at the office of The Municipal Development and Lending Fund- MDLF, **MDLF Procurement Manager, Eng. Ahmad Zayed** at the address given below at 08:00 AM to 04:00 PM from Sunday to Thursday.
4. A complete set of bidding documents may be purchased by interested bidders on the submission of a written application to the above and upon payment of a non-refundable fee of **Three Hundred (300) Euro** or equivalent amount of freely convertible currency. The method of payment will be in a direct bank deposit to The Municipal Development and Lending Fund-MDLF account number **174434, The National Bank**, Al Masyoun Branch.

5. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the Agence Française de Développement's *Standard Bidding Documents: Procurement of Works*.
6. Bids must be delivered to the above office on or before **12:00 afternoon local time on Thursday, 21/06/2018**. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person or on-line at the address below at **12:00 afternoon local time, 21/06/2018** at the office of MDLF.
7. All bids must be accompanied by a *bid security* of **80,000 Euro** or an equivalent amount in freely convertible currency and shall be valid for **148 days** counted from the date of bid submission deadline (*i.e. 16/11/2018*).
