1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business*, issue no. OP00025758 of 28 January, 2014.

2. The Palestine Liberation Organization, for the benefit of the Palestinian Authority (PA), has received financing in the amount of US\$ 29.76 Million from the World Bank-International Development Association (IDA), the French Development Agency (AFD), and the European Union (EU) towards the cost of the Gaza Solid Waste Management Project (GSWMP). The Municipal Development and Lending Fund (MDLF), as the delegated implementing agency, intends to apply part of the proceeds of this grant to payments under the Contract for Supply of Landfill equipment, Ref. 2.1.1.9.

3. The Municipal Development and Lending Fund - MDLF now invites sealed bids from eligible and qualified bidders for Supply of landfill equipment. The bid is comprised of the following 5 lots:

Lot No. 1: Supply of 4WD Tractor, Ref. 2.1.1.9-A

Lot No. 2: Supply of Track Type Tractor Waste Handler, Ref. 2.1.1.9-B

Lot No. 3: Supply of Loaders and Landfill Compactor, Ref. 2.1.1.9-C

Lot No. 4: Supply of Dump and Vacuum/Jetter Trucks, Ref. 2.1.1.9-D

Lot No. 5: Supply of Thermal Fogger, Ref. 2.1.1.9-E

4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits* published by the World Bank in January 2011, revised in July 2014. Bidding is open to all bidders from Eligible Source Countries as defined in the Guidelines.

5. Interested eligible bidders may obtain further information from (The Municipal Development and Lending Fund-MDLF, procurement and contracts manager, Eng.

Ahmad Zayed) and inspect the Bidding Documents at the address given below at 08:00 AM to 04:00 PM from Sunday to Thursday.

6. Qualifications requirements include a list of technical, financial and legal requirements. A margin of preference for certain goods manufactured domestically shall not be applied. Additional details are presented in the Bidding Documents.

7. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written Application to the address below from 08:00 AM to 04:00 PM-from Sunday to Thursday and upon payment of a nonrefundable fee **Two Hundred Euro (200 Euro)** or equivalent amount of freely convertible currency. The method of payment will be *in* a direct bank deposit to The Municipal Development and Lending Fund-MDLF account number (174434), The National Bank, Al Masyoun Branch. The Bidding Documents will be sent by airmail for overseas delivery and by courier or through the supplier's representative for local delivery.

8. The project is VAT Excluded.

9. Bids must be delivered to the address below at or before 11/02/2018, 14:00 PM local time. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person or on-line at the address below at 14:00 PM local time, 11/02/2018. All bids must be accompanied by a bid security of **2,000 Euro for lot no.1, 15,000 Euro for lot no. 2, 25,000 Euro for lot no.3, 12,000 Euro for lot no.4, and 1,000 Euro for lot no.5** or an equivalent amount in freely convertible currency and shall be valid for 148 days counted from the date of bid opening.
