The Palestine Liberation Organization, for the benefit of the Palestinian National Authority (PNA), has received financing in the equivalent amount of 61.97 Million Euro from several Financing Partners including the Agence Francaise de Development (AFD), the Danish Government, the Swedish International Development Cooperation Agency (SIDA), the World Bank, the German Development Bank (KFW), the German Technical Cooperation (GIZ), the Belgium Government, The European Union (EU), the Swiss Agency for Development and Cooperation (SDC), and the International Cooperation Agency of the Association of Netherlands Municipalities (VNG), towards the cost of the Municipal Development Program (MDP) Phase II – Cycle II in addition to the PNA contribution. 2. **MDLF** now invites sealed bids from eligible and qualified bidders for carrying out **“Supply of IT Equipment for O&M – West Bank”**.

3. Bidding will be conducted through the National Competitive Bidding (**NCB**) procedure specified in the World Bank Procurement Guidelines and is open to all bidders from Eligible Source Countries, as defined in the Bidding Documents.
