MDLF intends to apply part of the proceeds under Project “**Municipal Development Program IV (MDPIV)**” financed by *the World Bank-International Development Association (IDA), MDTF (administered by the World Bank), PA, KFW, Denmark, the Belgian Development Agency (Enabel), SDC, GIZ, EU and AFD* toward payment under the Contract “**Physical Inspection and Data Collection for O&M / West Bank, No.: MDP4C1-2.a/#5.A**” (hereinafter called “the Services”).
