Request for Proposals (RFPs) will be sent to the shortlisted firms. firms will be selected under ***Selection based on Quality-Cost Based Selection (QCBS)*** in accordance with the provisions of *the World Bank’s Procurement Regulations for IPF Borrowers, fourth edition dated November 2020 first published in July, 2016; and the “Guidelines on Preventing and Combating Fraud and Corruption in Projects Financed by IBRD loans and IDA Credits and Grants” dated January 2011.*
4. Interested eligible firms may inspect the Request for Expressions of Interest (RFEI) through the Public Procurement Portal and obtain further information from **MDLF** during office hours 8:00 AM to 3:00 PM from Sunday to Thursday at the address given below.
